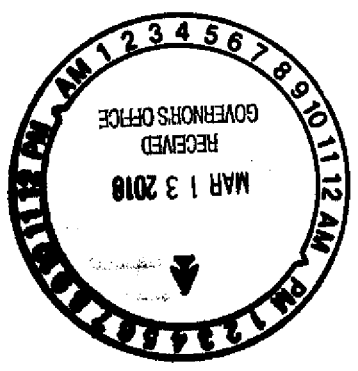

2 ENROLLED, An Act,

3           Relating to government agencies and offices; to  
4 permit the use of the national motto of "In God We Trust" by  
5 government agencies and offices, in and on public buildings,  
6 including government office buildings, public school  
7 classrooms, and on vehicles.

8 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

9           Section 1. This act shall be know as the National  
10 Motto "In God We Trust" Act.

11           Section 2. The governing body of any political  
12 subdivision of the state or any state agency may display the  
13 national motto of "In God We Trust" in and on public buildings  
14 and public vehicles, including, but not limited to any of the  
15 following:

- 16           (1) School classrooms.  
17           (2) Courthouses.  
18           (3) Libraries.  
19           (4) Office buildings.  
20           (5) Law enforcement or service vehicles.

21           Section 3. This act shall become effective on the  
22 first day of the third month following its passage and  
23 approval by the Governor, or its otherwise becoming law.
