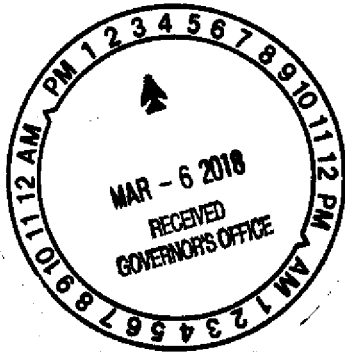

3 Relating to Escambia County; to amend Section
4 45-27-100 of the Code of Alabama 1975; to increase the
5 compensation of the members of the board of education.

6 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

7 Section 1. Section 45-27-100 of the Code of Alabama
8 1975, is amended to read as follows:

9 "\$45-27-100.

10 "(a) Beginning May 1, 2018, members of the Board of
11 Education of Escambia County shall each receive as
12 compensation from the public school funds of the county ~~three~~
13 ~~hundred dollars (\$300)~~ eight hundred dollars (\$800) per month
14 for attending meetings of the board and transacting the
15 business of the board. ~~This sum shall be paid in lieu of any~~
16 ~~salary.~~

17 "(b) Expenses shall be paid to the board members as
18 presently provided for by law."

19 Section 2. This act shall become effective
20 immediately following its passage and approval by the
21 Governor, or its otherwise becoming law.
